The Principal Offg. informed the members that Dr. Shantesh deposited the amount of Rs.9,32,609/- for the salary paid to him during his study leave w.e.f.18-8-2018 to 30-6-2019 and he was relieved from the services of the College on 14-02-2020. The Principal further informed that Dr. Shantesh vide his application dated 22-01-2020 requested for waiver of proportionate amount to be refunded with respect to leave salary, allowances and other expenses incurred to him by the College during his Study Leave.

The matter was discussed in detail and the members of the Governing Body unanimously recommended to consider the request of Dr. Shantesh for waiver of proportionate amount deposited by him with respect to leave salary, allowances and

other expenses incurred to him by the College during his Study Leave. The Chairman, Governing Body was authorized to check the legality of the case and take the decision further.

Note: Dr. Shantesh Kumar Singh, Assistant Professor in the Department of Polifical Science was Granted Study leave (with full pay) w.e.f 18-8-2018 to 30-6-2019 for pursuing post doctorate. As per study leave rules he had to serve the college for the equal period of Study Leave but in the meantime he was appointed as Associate Professor Department of Political Science, Central University of Haryana, Mahendergarh, Haryana. Dr. Shantesh requested the College to relieve him to enable him to join as Associate Professor in the Department of Political Science in the Central University Haryana on EOL with Lien for one year. The college asked Dr. Shantesh to deposit the salary for the study leave period amounting to Rs. 9,32,609/-. Dr. Shantesh deposited the same and also requested for waiver of proportionate amount to be refunded with respect to leave salary, allowances and other expenses incurred to him by the College during his Study Leave vide his application date 22-01-2020.

12. To report and consider the request received through email dated 04-03-2020 from Maj. Gen. K.T. Gajria (Retd.), Sole Arbitrator in the case of Arbitration Petition No.216/2010, M/s. A. K. Builders, Engineers & Contractors Vs. Shaheed Bhagat Singh College for payment of Rs.1,71,206/- as Arbitral Fees as per Sch IV of the Act out of the total amount of Rs.3,42,412/-.

The Principal Offg. explained the case to all the members of the Governing Body. The Principal further informed that the College received the request through email dated 04-03-2020 from Maj. Gen. K.T. Gajria (Retd.), Sole Arbitrator in the case of Arbitration Petition No.216/2010, M/s. A. K. Builders, Engineers & Contractors Vs. Shaheed Bhagat Singh College for payment of Rs.1,71,206/- as Arbitral Fees as per Sch IV of the Act out of the total amount of Rs.3,42,412/-.

The Principal Offg. informed the members that the College vide letter/email dated August 26, 2020 requested Mr. Girindra Kumar Pathak, Advocate appointed by the College for the said course, to check into the Act about the claim submitted by the Sole Arbitrator in the light of relevant rules and schedules of the Act and also requested to submit his recommendation in this regard at the earliest.

The Principal further informed that in response to College e-mail/letter, Mr. Girindra Kumar Pathak vide his letter dated 29th August, 2020 informed as under:

"In view of the referred terms and provisions apparently, the Ld. Arbitrator has fixed the Arbitral fee beyond the statutory provision which must prevail of any mutually agreed fee in the present case.

He is of the opinion that the Ld. Arbitrator be apprised to reconsider the Arbitral Fee within the frame work of statutory provisions."

After the detailed discussion, the Governing Body decided that Ld. Arbitrator be requested to rationalize the Arbitral Fees or he needs to justify the fees as asked by him. The Chairman, Governing Body and Mr. Sunil Gupta, Member, Governing Body were authorized to decide the fees to be paid to Ld. Arbitrator after obtaining necessary clarification as stated above.

Note: Mr. Maj. Gen. K. T. Gajria was appointed as Arbitrator by the University of Delhi in the case of M/s. A. K. Builders, Engineers & Contractors Vs. Shaheed Bhagat Singh College. The university also informed the College vide its letter No.CS-SDC/124/SBSC/2019/101 dated 6th May, 2019 that the fee for the Arbitrator and the expenses may be borne by the parties as mutually agreed or as per the Contract Agreement. The College appointed Mr. Girindra Kumar Pathak, Advocate, Hon'ble District Court, Dwarka, New Delhi with the approval of the Governing Body out of the panel of advocates of University of Delhi to represent the case on behalf of the College for future hearings. The case pertains to construction of rooms at the second floor and partitions in the existing hall of the evening classes of the Shaheed Bhagat Singh College in the year 1997.

- 18. To consider the status of vacant post of Teaching and Non-teaching and appointment of Assistant Professor on ad-hoc basis in different departments of the College.

The Principal Offg. informed the members that the University Grants Commission sanctioned 170 teaching posts to the College. Presently, 87 teachers have been working on permanent basis and 55 on adhoc basis. There is a requirement of ad-hoc teachers as per workload for Semester-I/III/V for the academic session 2020-2021.

The Principal further informed that the admissions for Semester-I for the Academic Session 2020-2021 may start in the first of week of October, 2020. For smooth conduct of teaching learning of Semester-I/III/V, the College needs to appoint ad-hoc teachers as per workload for Semester-I/III/V for the academic session 2020-21 up to a maximum limit of 170 in all.

The Principal further informed that the College appointed 30 guest faculties in the last semester (2019-20) as per workload approved by the Workload and Time Table Committee of the College. The Teachers-in-charge of different department for the current academic session requested to appoint the faculty on ad-hoc basis for smooth conduct of teaching learning in the College.

The Principal Offg. proposed that College may appoint the ad-hoc faculty as per workload approved by the Workload and Time Table Committee of the College for Semester-I/III/V for the academic session 2020-21 up to a maximum limit of 170 in all.

The Principal further informed the members that present workload is far more than sanctioned limit of 170 due to factor of EWS and UGC has not given extra teachers. The Governing Body suggested to write to authorities for sanctioning of more teachers. Till that time, teachers should take extra workload by making adjustments in the size of the tutorials. Group size of tutorials be increased. Students interest must be protected.

The Governing Body decided that the College should check with other colleges regarding appointment of ad-hoc faculty in the College. The matter was processed administratively and the Chairman, Governing was informed verbally on 22nd August, 2020, about the complaints received between 14 to 18 August, 2020. The concerned teachers were requested to give their observations and comments. The complete file with all detail was placed before the Chairman, Governing Body on 28-08-2020 for his kind information and directions in the matter. The Chairman, Governing Body directed to present the case in the Governing Body meeting.

The Principal further shared with the Governing Body that it is now the whole house to guide and direct how the matter should be resolved as the charges made are very serious in nature. There were discussions in the Governing Body and it was resolved that the Chairman, Governing Body should try to resolve this matter in already formed Grievance Committee and may have to nominate the names of Faculty Members to act as members of the Grievance Committee and give further directions in the matter to look into the complaints received from Dr. Arun Kumar Attree, Dr. Shikha Gupta, Dr. Kalpana Gupta, Dr. Sonika Sharma and Dr. Rakesh Kumar and Dr. Anil Kumar, Teacher-in-Charge, Department of Commerce.
