MINUTES OF THE MEETING OF THE GOVERNING BODY HELD ON THURSDAY, 10th JUNE, 2021 AT 3:00 P.M. IN THE COLLEGE.

The items on the agenda were taken up ad seriatim and the following decisions were taken:

1. To confirm the Minutes of the meeting of the Governing Body held on 4th March, 2021 and the matters arising out of the Minutes.

The Governing Body ratified and confirmed the Minutes of the meeting of the Governing Body held on 4th March, 2021 and there was no matter arising out of the Minutes.

2. To ratify and confirm the recommendations of the Building Committee made at its meeting held on 10th June, 2021

The Governing Body ratified and confirmed the recommendations of the Building Committee made at its meeting held on 10th June, 2021 as per detail given below:

To consider the Report received from the Sub-Committee constituted by the Building Committee, in its meeting held on 06-10-2020, to review the bills with regard to the extra items/additional work executed by the Contractor for renovation of Geography Department in the College.

The Principal informed the Governing Body that the meeting of the Building Committee was presided over by the Chairman, Governing Body. The Treasurer, Governing Body also attended the meeting along with other members of the Committee.

The Principal informed the Governing Body that M/s. Creators Engineer and Interiors was awarded the contract for renovation of Geography Department at a cost of Rs.28,66,095/-

with the approval of the Governing Body, but the contractor has executed the above said works for Rs. 42,40,055/-. There are additional/extra items/works for Rs. 8,84,397/-.

The Principal further informed that the College has not issued any order for extra work. The Architect also informed that he has also not received any communication from the College with regard to extra items/additional work given by the College to the Contractor for renovation of Geography Department. He further said that he cautioned the contractor that these extra items are not specified in the tender.

The Principal further informed the Governing Body that the report was received from the Sub-Committee and the same was placed before the Building Committee for consideration. As per report received, the Sub-Committee was of the considered view that bills submitted by M/s. Creators Engg. & Interiors with regard to extra work done are justified and the Sub-Committee recommended that the payment may be released by the Competent Authority for the same.

The Principal further informed that the Architect has submitted his report vide its letter No. SKA/SBS/41/2020 dated 03-12-2020 with regard to detail of the extra work done amounting to Rs.8,84,397/-.

The Principal further reported that the College has received an email dated 08-06-2021 from Dr. Kavita Arora, Teacher-in-Charge, Department of Geography requesting for approval and to release the payment against the extra work done by M/s. Creators Engineer and Interiors in the Geography Department and the request of the TIC was endorsed by all the faculty members of the Geography Department.

The Principal further informed the Governing Body that as requested and endorsed by the faculty members of the Department of Geography, recommended by the Sub-Committee and bill examined and certified by the Architect of the College, the Building Committee accorded its ex-facto approval to the extra work done and decided to release the payment amounting to Rs.8,84,397/- to M/s. Creators Engineer and Interiors with regard to extra work done in Geography Department. It was decided that the matter may be placed before the Governing Body for approval.

After the deliberations, the Governing Body accorded its ex-facto approval to the extra work done and decided to release the payment amounting to Rs.8,84,397/- to M/s. Creators Engineer and Interiors with regard to extra work done in Geography Department as requested and endorsed by the faculty members of the Department of Geography, bills examined and certified by the Architect of the College, recommended by the Sub-Committee and Building Committee.

ii. To consider the Report received from the Sub-Committee constituted by the Building Committee, in its meeting held on 06-10-2020, to verify and examine the records relating to relocation of Bamboo structure in the College by M/s. Mascot Interiors Pvt. Ltd. and to state the reasons for extra work done and make their recommendation.

The Principal informed the Governing Body that a Sub-Committee was constituted to verify and examine the records relating to relocation of Bamboo structure in the College by M/s. Mascot Interiors Pvt. Ltd.. The Principal further informed the Governing Body that the report has been received from the Sub-Committee. As per report received, the Sub-Committee is of

the considered opinion that additional work was the genuine requirement of the college infrastructure. Further, the increased work has the recommendation of the then Principal and the approval of the then Chairman Governing Body. The Architect also verified the additional work and therefore, the additional payment to the said vendor for the additional work done shall be made after mandatory deductions and tender document should be referred in this case. The report of the Sub-Committee was placed before the Building Committee for consideration.

The Principal further informed the Governing Body that the Building Committee approved to release the payment amounting to Rs.1,82,400/- for the additional work as recommended by the Sub-Committee and the bill examined and verified by the Architect of the College. The Building Committee decided that M/s. Mascot Interiors Pvt. Ltd. be requested to remove/relocate the malwa from where the bamboo rooms were shifted to near the main entrance gate of the College. The Building Committee also decided that an amount of Rs.20,000/- be withheld and the same be released to the firm after removing/relocating the malwa from the said area. The Building Committee approved to release the payment amounting to Rs.1,62,400/-.

The Governing Body ratified and approved the above recommendations of the Building Committee to release the payment amounting to Rs.1,62,400/- to M/s. Mascot Interiors Pvt. Ltd.

iii. To consider the Report received from the Sub-Committee constituted by the Building Committee to explore the feasibility of installation of Solar Panel in the College.

The Prinicpal informed that the Governing Body that the Item No. 4 of the agenda was deferred. It was noted.

iv. To consider the Report received from the Sub-Committee constituted by the Building Committee, in its meeting held on 06-10-2020, to submit the afresh/revised proposal with regard to renovation of First, Second and Third Floor of the Library and revise cost estimates.

The Principal informed the Governing Body that the Building Committee, in its meeting held on 06-10-2020, constituted a Sub-Committee to submit the afresh/revised proposal with regard to renovation of First, Second and Third Floor of the Library and revise cost estimates.

The Principal informed the members that the report has been received from the Sub-Committee and the same was placed before the Building Committee for consideration.

The Principal further informed that as per report of the Sub-Committee visited the library and examined the requirements. After assessing the requirements of the students and library administration, the Sub-Committee requested the Architect to prepare the drawings and estimates accordingly. The Architect submitted the revised estimates vide his letter No.SKA/SBS/42/2020 dated 9.12.2020 amounting to Rs.2,79,00,000/-. The Sub-Committee, in its report, recommended to float the tender and to get the renovation of first, second and third floor of the library.

The Principal informed the Governing Body that the Building Committee approved in principal the estimated costs of the tender amounting to Rs.2,79,00,000/- as received from the Architect and recommended by the Sub-Committee. The Building Committee desired that the details of the items must be included only of those items which are essential and

necessary as per requirements of the students and library administration. Therefore, the Building Committee decided that the Sub-Committee be requested to go through the tender document and details of items given in the tender document again and make their recommendations. The Chairman, Governing Body was requested to study the revised cost and details and give his opinion to which he agreed to help.

The Governing Body ratified and approved the above recommendations of the Building Committee and estimated costs of the tender amounting to Rs.2,79,00,000/-.
