



It was reported that cleaning and sanitation services for both Day and Evening College were outsourced to M/s. Sulabh International vide orders of the Chairman. The Day College would make the payment of Rs.1,10,893/- per month inclusive of cleaning materials and the Evening College would make the payment of Rs.46,290/- per month inclusive of cleaning materials.

18. To consider for approval the appointment of M/s. Studio Plus as an Architect for the following projects:


a. Repairs and renovation work of the College (both Morning and Evening

## Note:

- i. It was decided by the Joint Development Committee (Joint Development Committee comprises of members from both 'Day' and Eve' College and was constituted with the due approval of the Chairman, Governing Body -in its meeting held on 16th January, 2012 that M/s Studio Plus should be retained as an Architect with respect to repair and renovation work and carpeting and internal tiling of internal roads against payment of fee @ 2%.
- ii. The matter was also placed before the Building Committee in its meeting held on 7th February, 2012 and it was decided by the Building Committee that M/s. Studio Plus be asked to make a presentation before the Joint Development Committee for the above projects and that the fee of 2% of the actual cost, as recommended by the Joint Development Committee be negotiated with M/s. Studio Plus at the time of presentation



With respect to the above, a presentation was made by the Architect, M/s. Studio Plus, before the Joint Development Committee in its meeting held on17<sup>th</sup> February, 2012 and negotiations were held with M/s. Studio Plus with respect to the projects related to (a) and (b) above. After negotiation, M/s. Studio Plus agreed to charge a fee of 1.8% of the actual cost of the above two projects as against 2% which he had quoted earlier.

The Governing Body approved the appointment of Architect, M/s. Studio Plus, for the aforesaid projects, as recommended by the Joint Development Committee and also approved the recommendation of the Joint Development Committee to pay a fee of Rs.1.8% of the actual cost of the above two projects.



The Governing Body confirmed the appointment of the above Assistant Professors in the College in Departments noted against their names on the recommendations of the Selection Committees in the Academic Year 2011-12, i.e., w.e.f. July 21, 2011 to May 21, 2012 in the Pay Band of Rs. 15600-39100 with AGP of Rs.6000 as per details given above.

26. To consider the requests received from Dr. B.C. Sehgal, Offg. Principal (Retired on 31-07-2011) and Mr. K.C. Georgekutty, Section Officer, Accounts (Retired on 31-05-2011) regarding fixation of their pension.

It was reported that Dr. B.C. Sehgal, Offg. Principal retired on 31-07-2011 and Mr. K.C. Georgekutty, Section Officer, Accounts retired on 31-05-2011. As per the records available in the College office, they had continued under the C.P.F. scheme till January, 1999 and thereafter they switched over from C.P.F. to G.P.F. in accordance with University Notification No. Fin/Pen.Cell/Notif./98/28863 dated 30-11-1998 vide E.C. Resolution No.132. Both the employees have reported that approval to the fixation of their pension by the University of Delhi has not been done so far. The Governing Body considered their requests and decided to recommend to the University of Delhi for the earlier fixation of their pension as per rules.

27. To consider the letter No. SDC/CB/Seniority/SBSC/2011/233 dated August 4, 2011 received from the University of Delhi South Campus regarding the representation of Dr. S.B. Saxena claiming seniority over Dr. G.K. Kapoor

The Chairman placed before the Governing Body a letter dated SDC/CB/Seniority/SBSC/2011/233 dated August 4, 2011 received from the University of Delhi South Campus enclosing therewith the representation of Dr. S.B. Saxena claiming seniority over Dr. G.K. Kapoor.

The Governing Body unanimously reiterated the decision of the University of Delhi South Campus and upheld the seniority between Dr. G.K.Kapoor and Dr. S.B.Saxena as determined by the University vide its letter No. SDC/CB/Seniority/SBSC/2011/233 dated August 4, 2011.

The Governing Body noted that Dr. G.K.Kapoor, Officiating Principal, is superannuating on 30.04.2012 and decided to authorize the Chairman, Governing Body to make the necessary arrangements for the appointment of next Principal.

Thereafter the meeting continued to take up the agenda of the Evening College.
