The College has appointed Mr. Mohinder J. S. Rupal, Advocate, High Court of Delhi out of the panel of advocates of University of Delhi and he has filed the case in High Court on 01st July, 2019.

Note: The College received a letter dated 16.04.2019 along with judgement decided by the Court of Sh. Manish Markan Ld. ADJ Saket Court, Delhi from Mr. J.H. Jafri, Advocate, Supreme Court of India appointed by the College for Civil Case Bearing No. 6567/2016 titled as M/S Yadav Electricals Pvt. Ltd. versus the Principal, Shaheed Bhagat Singh College.

The conclusion/judgement of the case is given below:

"In view of the findings given above, the suit of the plaintiff is decreed for a sum of Rs.6,72,126/- in favour of the plaintiff and against defendant No. 1 only. Plaintiff is entitled to simple interest@ 12% per annum on this amount from 15.05.2007 till filing of the suit i.e. 10.05.2010 and on the suit amount, plaintiff is also entitled to pendent lite and future interest @9% per annum alongwith costs of the suit. Decree sheet be prepared."

10. To report about the Architect, M/s. S. Kumar and Associates, progress of construction work undertaken by the College.

The Acting Principal reported that a meeting with the Architect, M/s. S. Kumar and Associates was held in March, 2019 and he also sent the letters to the Architect, nothing concrete could be done for small welfare projects as approvedby the Governing Body. The Acting Principal shared the whole report and and performance of the Architect with the

Governing Body. The Acting Principal further shared that certain works of very small nature but of utility to physically challenged students and general services are suffering. The Governing Body decided that in addition to the present architect, College should hire the services of other architects/consultant engineer on work basis. The services of architect/consultant engineer can be hired for stand alone project or two-three projects can be combined.

11. Miscellaneous Reporting matters

i) Appointment of Officials on rotation basis as per seniority list of teachers.

Some of the Teacher Representatives on the Governing Body presented a request signed by 34 teachers of the College, addressed to the Chairman, Governing Body regarding appointment of following officials on rotation basis on the basis of seniority of the teachers:

- a) SC/ST Liaison Officer
- b) OBC Liaison Officer
- c) PIO
- d) Various Nodal Officers
- e) Bursar
- f) Director, IQAC
- g) Coordinator, SOL

The letter was placed before the Governing Body for consideration. After the detailed discussion, the Chairman, Governing Body requested the Acting Principal to look into the matter and do wide consultation and decide the matter. He also requested that based on the consultation and rules, give appropriate representation to all sections of the College.

ii) Promotion of Teaching and Non-Teaching Staff Members of the College

The Acting Principal reported that the promotions of teaching and non-teaching staff are due since long. The Governing Body authorized the Acting Principal to take all necessary steps for the promotions of teaching and non-teaching staff members working in the College.

iii) Innovation Projects

The Chairman suggested that Innovaation Projects should be started in the College to be mentored by teachrs of the College. The College should charge Rs.300/- per student to meet the expenditure on the activities of this programme. Money so collected should go to Teachers Research fund.

The Governing Body resolved and approved to start the Innovation Projects to be mentored by teaches of the College and decided that an amount of Rs.300/- per student be charged to meet the expenditure on the activities of this programme. Departments will

make the criteria for selecting innovation projects to be undertaken and allotted to students.

iv) To improve the hygiene and services of Canteen of the College

The Governing Body members, representative non-teaching, complained about services of the canteen, unhygienic conditions and bad quality raw material being used by canteen contractor. The Chairman suggested that the tender for award of Canteen Contractor, to run the canteen, should be floated on yearly basis for maintaining hygiene and better services to the stakeholder of the College. It was also suggested that a Monitoring Committee should be constituted to monitor the cleanliness, hygiene and food quality provided by the Canteen Contractor on day to day basis. The Governing Body authrorised the Acting Principal to take all necessary steps for maintaining hygiene and better services to the stakeholder of the College by the Canteen Contractor. All stakeholders should represent the Committee. Students interest should be proctected for various services in the College.

v) Construction of temporary cemented stage and shed

The Acting Principal informed the members that various department societies of the Day College as well as Evening College organize various functions including their Annual Fest. At these functions, a stage is erected with the help of tent houses. A lot of expenditure is incurred by different societies together on these activities. An inter-college cultural-cum-union fest also involves erection of stage in the Play ground involving lot of expenditure. These expenditures are incurred year after year. The College can save lot of money if a cemented stage and temporary shed of appropriate size is constructed in parking area as well as in the play ground of the College for the conduct of various programmes by the students' society/committees and inter-college cultural-cum-union fest. The Governing Body noted that College would save lot of money which is being spent on payment to the tent houses for College activities. The Governing Body appreciated this initiative.

The Governing Body appointed Dr. Kavita Arora, Assistant Professor, Department of Geography as Convener to take all necessary steps for the construction of cemented stage and temporary shed of appropriate size at parking area as well as in the play ground of the College for the conduct of various programmes by the students' society/committees and inter-college cultural-cum-union fest in the play ground by following requisite procedure and GFR rules.

There being no other item, agenda of the Evening College was taken up.
