MINUTES OF THE EMERGENT MEETING OF THE GOVERNING BODY HELD ON 28th AUGUST, 2019 AT 3:30 P.M. IN THE COLLEGE PREMISES.

An emergent meeting of the Governing Body of the College was held on 28th August, 2019 at 3:30 p.m. in the College.

The Acting Principal reported that according to Clause 7(3) of Ordinance XVIII, the casual vacancy is to be filled by the senor-most Associate Professor who fulfills the eligibility conditions for appointment as Principal of the College including Research Score of 110 points as per UGC Gazetter Notificate dated July 19, 2018. According to the records available with the College, Dr. Sudhir Kumar Sinha is senior to Dr. O.S. Deol and Dr. C.S. Dubey.

The Acting Principal further reported that the Governing Body, at its meeting held on 29th July, 2019, considered the minutes of the Screening Committee and concluded that Dr. Sudhir Kumar Sinha, Associate Professor in the Department of Geography is eligible in terms of the qualifications laid down in the University Grants Commission Gazette Notificated dated 18th July, 2018.

Accordingly, the Governing Body asked Dr. S. K. Sinha to look after the work of Principal, Shaheed Bhagat Singh Evening College till further orders or for a period of six months or till such time regular Principal is appointed, whichever is earlier and take over the charge from Dr. P.K. Khurana on 31st July, 2019 (A/N). It was also decided that the above arrangement shall be subject to the outcome of the Writ Petition (Civil) No.3433/2019) in the matter of Dr. Sudhir Kumar Sinha Vs. Univrsity of Delhi & Ors. in the Hon'ble High Court of Delhi.

The Acting Principal further reported that as per the decision of the Governing Body made at its meeting held on 29th July, 2019, Dr. S. K. Sinha took the charge from Dr. P.K. Khurana on 31st July, 2019 (A/N) to look after the work of Principal, Shaheed Bhagat Singh Evening College.

The Acting Principal further reported that Dr. S. K. Sinha vide his letter dated 26th August, 2019 informed that he has withdrawn the Writ Petition (Civil) No.3433/2019) in the matter of Dr. Sudhir Kumar Sinha Vs. Univrsity of Delhi & Ors. in the Hon'ble High Court of Delhi and the Hon'ble Court has ordered withdrawal of the same.

The orders passed by the Hon'ble Higher Court of Delhi dated 26-08-2019 are given below:

"While the counsel appearing for the respondent – University of Delhi submits that the instructions from the respondent are still awaited, ld. Counsel for the petitioner comes forward to withdraw the instant petition stating that in view of the decision of the Governing Body dated 29-07-2019, the petitioner has been offered to look after the work of the Principal vide communication dated 30-07-2019 and joined as well on 31-07-2019. Liberty is however sought to approach the court afresh, if the need arises.

Dismissed as withdrawn, as prayed, Pending applications stand disposed off accordingly.

Date earlier fixed stands cancelled."

After considering the above fact, the Governing Body unanimously approved the name of Dr. S. K. Sinha for appointment as Acting/Officiating Principal of Shaheed Bhagat Singh (Evening) College.

This Resolution of the Governing Body be forwarded to the University of Delhi for its approval.
