Scope of Work:

The selected firms/consultants will be required to provide services for:

- Designing, planning, and preparing electrical diagrams for transformers, LT Panels, and related electrical infrastructure.
- Assessment and load calculation for transformer capacity and distribution.
- Supervision of installation, commissioning, and testing of electrical components.
- Ensuring compliance with safety norms, regulatory approvals, and government standards.
- Providing technical guidance and quality assurance for electrical works.

Eligibility Criteria: Technical Bid

The consultant/electrical engineer having following valid documents will be technically qualified and considered for opening of their price/financial bid. Technically qualified parties have no right to claim for award of the work. The College reserves the right to cancel or award the work to any party/bidder without assigning any reason. - 2. The empaneled consultant shall ensure that all electrical designs and plans comply with relevant government regulations, safety standards, and power distribution norms.
- 3. The empaneled consultant shall not sublet or transfer the awarded work without prior approval from the College.
- 4. Payment shall be made in phases as per the progress of the work and in compliance with the agreed contractual terms.
- 5. The college reserves the right to terminate the empanelment in case of unsatisfactory performance, non-compliance with contract terms, or any other valid reason.
- 6. All designs and documents prepared by the empaneled consultant shall remain the property of Shaheed Bhagat Singh College.
- 7. Any dispute arising out of this empanelment process shall be subject to the jurisdiction of Delhi courts.
- 8. The college reserves the right to reject any or all applications without assigning any reason.
- 9. The interested consultant/engineer are advised to visit and inspect the site and its surrounding and satisfy themselves before submitting the **EoI** and obtain all necessary information which they feel is necessary to submit their **EoI**.
- 10. The consultant is required to prepare & submit the required drawing & details for approval of the drawings, plans/ obtaining Clearances from the Competent Authority/Statutory Bodies such as MCD, DDA, and Electrical Departments (as applicable) according to the local Acts,

Laws, Regulations etc. and make any changes desired by such authorities and obtain final approval and completion certificate from these authorities after completion of the building if required.

- 11. The College without any prejudice to its right against the consultant/electrical engineer in respect of any delay or otherwise or to any claims or damages in respect of any breaches of the contracts and without prejudice to any rights or remedies under any of the provisions of this contract, may terminate the contract by giving one month's notice in writing to the consultant/electrical engineer and in the event of such termination, the consultant/electrical engineer shall be liable to refund the excess payment, if any, made to him over and above what is due in terms of this agreement on the date of termination and the College may make full use of all or any of the drawings prepared by the Architects.
- 12. Termination of the Contract by the Architects shall be subject to levy of a suitable compensation by the College, quantum of which shall be decided by the Competent Authority.
- 13. The College agrees to pay fee on the actual cost of the work done to the Architects for the professional services to be rendered by them as herein above described at Clauses (I, II, III & IV) as described above at Annexure-I. The payment will be released as per University rules.
- 14. Merely submission of Expression of Interest does not guarantee empanelment of the architect and the College reserves its right to shortlist and empanel the architect on the basis of their credentials viz., experience, works done and past performance, etc. The interested and eligible candidates may be called for personal interaction/presentation.
