3. College Identity Card
4. Category Certificate (SC/ST/PwBD/EWS/OBC), if applicable
5. Marksheet/Statement of Marks of the previous semester/class
6. Bank Statement/Passbook of parent(s) for the last six months
7. 1st Year Students – Undertaking that the student will always maintain the minimum attendance requirement of 66.67%
8. 2nd, 3rd & 4th Year Students – Proof of minimum 66.67% attendance in the preceding semester
