### NOTICE INVITING EXPRESSION OF INTEREST (EOI)

#### For Management, Operation and Development of Cricket Ground Facilities

Shaheed Bhagat Singh College invites sealed **Expressions of Interest (EOI)** from reputed, experienced and financially sound Sports Cricket Academies for entering into a **Memorandum of Understanding (MoU)** for the management, operation and development of the Cricket Ground and allied sports facilities situated within the College campus at Sheikh Sarai Phase-II, New Delhi.

#### 1. Scope of Work

The selected Sports Academy (hereinafter referred to as the "Second Party") shall undertake the following:

##### 1.1 Infrastructure Development

- Development and upgradation of cricket ground infrastructure at its own cost and risk.
- Installation/maintenance of turf wickets, practice nets, training pitches and outfield improvement.
- Installation of floodlights for day/night matches.
- Construction of dugouts, seating arrangements, store room, tuck shop, and allied amenities.
- Installation of DG generator, irrigation and drainage systems.
- Any other sports-related infrastructure, subject to prior approval of the College and compliance with applicable laws.

##### 1.2 Operations & Maintenance

- Complete responsibility for upkeep, maintenance and operational readiness of the cricket ground throughout the tenure of the MoU.
- Deployment of qualified coaches, curators and support staff.
- Conduct of cricket coaching programs, academy activities, tournaments and matches.
- Compliance with all safety norms, municipal regulations and statutory requirements.

All infrastructure investment and routine maintenance expenses shall be borne entirely by the selected Academy.

## 2. Operations and Usage Rights

The operational framework shall be governed as follows:

### 2.1 Weekdays (Monday to Friday)

- The College shall retain **primary and overriding rights** to use the Sports Facility for academic, institutional and sports purposes.
- Subject to institutional requirements and prior coordination with the College, the selected Academy/Coaching may with the prior permission of the college conduct cricket match.

### 2.2 Weekends and Public Holidays

- On Saturdays, Sundays and Public Holidays, the selected Academy shall have the right to:
  - Organize corporate cricket matches;
  - Conduct tournaments and recreational sports events;
  - Conduct academy matches and allied sports activities, including night matches using floodlights.
- If the College requires the ground on any weekend or public holiday, prior intimation shall be given sufficiently in advance for necessary coordination. In lieu of it college will allow one day use on alternative day.

## 3. Profit and Loss Sharing (Indicative)

- Weekday Matches (Monday-Friday only after prior approval of College):**

Net Profit (after deduction of electricity expenses) shall be shared as:

- College - 60%
- Academy - 40%
- Weekdays matches/use shall be so

- Weekends & Public Holidays:**

All Profit/Loss arising from events conducted on Saturdays, Sundays and public holidays shall belong entirely to the Academy, as it shall bear operational and maintenance costs.

- Profit/Loss sharing shall commence only after six (6) months from the date of execution of the MoU, or once the facility becomes fully operational whichever is earlier.

## 4. Eligibility Criteria

Interested Sports Cricket Academies must satisfy the following minimum eligibility conditions:

### 4.1 Experience

- The Academy must have been engaged in cricket coaching for a minimum period of at least **3 years**.

## 4.2 Financial Capacity

- The **average annual turnover** for the last three financial years:

- FY 2022-23
- FY 2023-24
- FY 2024-25

must not be less than **₹70,00,000 (Rupees Seventy Lakhs only)**.

(Audited financial statements and CA-certified turnover certificate must be submitted.)

## 4.3 Player Representation – District/State Level

- At least **15 players trained by the Academy must have represented** the Delhi & District Cricket Association (DDCA) at Junior and/or Senior level.  
(Documentary proof mandatory.)

## 4.4 National Representation

- At least **one player trained by the Academy must have represented India** at Junior or Senior level under the aegis of the Board of Control for Cricket in India (BCCI).  
(Documentary proof mandatory.)

## 5. Selection Criteria

5.1 The selection of the Coaching/Academy will be done through following 2 stages:

**Stage 1:** The Academy/ Coaching which fulfills the eligibility criteria mentioned in 4 above will be short listed for stage II

**Stage II:** The shortlisted academies/Coachings will be screened by the Selection Committee. Those shortlisted will be invited to interact with the Selection Committee to assess their suitability in meeting the requirements of the college.

## 6. Duration of MoU

The MoU shall be valid for an initial period of **five (5) years**, including a lock-in period, extendable for a further term subject to mutual consent and satisfactory performance.

## 7. Code of Conduct

Since the Sports Facility is located within an educational campus:

- Smoking, alcohol consumption and prohibited substances shall be strictly prohibited.
- Discipline, safety and decorum of the campus must be maintained at all times.
- The Academy shall ensure that activities do not disrupt academic functioning.
