All students of **Shaheed Bhagat Singh College** are hereby informed that the College is going to conduct the process for the **Students' Union** for 2026-27 as per the schedule given below:

1.	Last date for receipt of Nomination Papers	:	Thursday, the 10 th September, 2026 till 3:00 p.m. (Through official email of candidate only)
2.	Scrutiny of Nomination Papers	:	Thursday, the 10 th September, 2026 till 3:15 p.m.
3.	Publication of list of duly nominated Candidates	:	Thursday, the 10 th September, 2026 till 6:00 p.m.
4.	Last Date for Withdrawal of Nominations by the Candidates	:	Friday, the 11 th September, 2026 till 12:00 noon. (Through official email of candidate only)
5.	Publication of final list of Candidates	:	Friday, the 11 th September, 2026 till 5:00 p.m.
6.	Date of Election	:	Friday, the 18 th September, 2026
7.	Time of Voting	:	8:30 a.m. to 1:00 p.m.
8.	Counting of Votes	:	Immediately after Voting

1. As decided in the meeting held on 20.08.2026, to create awareness among the students on Lyngdoh Committee recommendations, University of Delhi Guidelines and various decisions of the Hon'ble Delhi High Court on the conduct of Students' elections process, the College will conduct a **MCQ based Quiz** on 2.09.2026 at 1:00 pm in the Room No. C-1. **The test will be voluntary and all candidates are encouraged to take active participation in the test.**

2. In order to promote **adequate representation and participation of women students**, **one post of Central Councillor (CC)** shall be reserved for a **women student** in the Students' Union.
3. In addition, **the post of Vice-President (V.P.)** shall be reserved for a **women student from the next year onwards**. In addition in order to promote adequate representation and participation of newly admitted students, the post of **Joint Secretary** shall be reserved for a **first year undergraduate student**.



4. The attendance of various cultural events and society participation will be considered while determining the minimum 75% attendance criteria.
5. The nomination form shall be accepted **only through online mode from the official email ID allotted to the concerned student by the College.** The duly filled nomination forms shall only be sent to studentsunion@sbs.du.ac.in, up to **10.09.2026 at 3:00 p.m.** (Nominations sent to any other email ID will not be accepted). Please note that Nominations sent from any other email ID will not be accepted. **Further, no nominations in physical form will be accepted.**
6. Students are required to duly fill in the nomination form and prepare all the requisite annexures, ensuring that **each page of every document is duly signed.** Thereafter, all the documents shall be arranged in the following order, **scanned, and compiled into a single PDF file and sent to email studentsunion@sbs.du.ac.in from students official email id issued by college.**
 - (i) Nomination form (Duly filled and signed)
 - (ii) Nomination Fee Receipt amounting to Rs.1,000/- (non-refundable)(duly Signed). The QR code for payment is attached herewith:-
 - (iii) Undertaking as prescribed in **Annexure A** (Duly signed on each page by the candidate)
 - (iv) Affidavit as prescribed as **Annexure B** (signed on each page by the candidate and notarised on e-Stamp Paper of Rs.10/-)
 - (v) Copy of College ID Card and Fee Receipt
 - (vi) Parent's Consent Form as prescribed as **Annexure C.**
 - (vii) Mark sheet (Last Examination Passed).



Note: In case the parent(s) of a candidate are residing outside Delhi, the candidate may obtain the duly signed Parent's Consent Form from either parent through WhatsApp or email and attach the copy of the same along with the required Consent Form as proof of parental consent. In such cases, the parent(s) are not required to travel to Delhi or be physically present to sign the Consent Form. However, any forgery, fabrication, or unauthorized reproduction of a parent's signature will be viewed seriously and may result in appropriate disciplinary and/or legal action against the candidate, as per the applicable rules.

The PDF file should be saved using the **First Name of the candidate followed by the post for which the candidate is contesting.** For example, if the candidate's name is **Nidhi Singh** and she is contesting for the post of **President**, the file name should be **Nidhi_President.pdf.**

Note: To avoid any technical glitches, server issues, network problems, or other unforeseen difficulties, students are advised **not to wait until the last moment to submit their nominations. No complaint of any technical glitch or server issue will be entertained** and it is the sole responsibility of the candidate that the nomination email reaches before the scheduled date and time. Further, the **official College email IDs of first-year students will be provided by 3rd September 2026.**

All students are advised to strictly adhere to the schedule, eligibility conditions and instructions issued by the College from time to time. Any change in the above schedule, if required, shall be notified separately.

Note: As per Lyngdoh committee guidelines 6.5.6

"The candidate shall have one opportunity to contest for the post of office bearer, and two opportunities to contest for the post of an executive member."

This provision implies that a candidate who has previously contested an election for the **post of Central Councillor** shall be eligible to contest again in the Students' Union Elections, including for the post of **Central Councillor or for any other post.**

However, a candidate who has previously contested an election for any of the **Office Bearer posts**, namely, **President, Vice-President, Secretary, or Joint Secretary**, shall **not be eligible to contest again for any of these Office Bearer posts** in the Students' Union Elections, but he can contest for Central Councilor post.

- My candidature is in compliance of lyngdoh committee guidelines 6.5.6,
"The candidate shall have one opportunity to contest for the post of office bearer, and two opportunities to contest for the post of an executive members."
- I do not have a previous criminal record, that is to say, I have not been tried and or convicted of any criminal offence or misdemeanour. I have also not been subject to any disciplinary action by the College / University authorities.

If elected, as Office bearers of SBSC Student Union I will abide by:

- That all Functions of Students Union will be held in the College during College hours.
- That I will not insist on inviting professional rock bands or pop artists in College Union Functions during the year 2026-2027 as per University and College guidelines.

- Canvassing inside the Class rooms when a teacher is teaching in the class.
- Sticking posters and bills or writing on the walls, inside and outside the College building, gates or boundary walls, except the handmade posters on the Wall of Democracy inside the College gate.
- Using any form of printed material for canvassing.
- Using loudspeakers or any other sound magnifying instruments for propaganda etc.
- Using Dholak, Harmonium, Trumpet or any other musicals instruments in or around the college premises.
- Threatening, intimidating or hurting bodily or otherwise any person.

- Using Dholak, Harmonium, Trumpet or any other musicals instruments in or around the college premises.
 - Threatening, intimidating or hurting bodily or otherwise any person.
 - Using obscene language.
 - Violation of Code of conduct prescribed by the University of Delhi as per Supreme Court Judgment.
 - Bribing by offer of money, be way of entertainment or any other way to influence the casting of votes.
 - Taking help of outsiders for canvassing and propaganda.
 - Making speeches and doing propaganda of the political nature.
 - Causing any damage to the name and property of the College.
- ii. The nomination papers including undertaking and affidavit are found to be incomplete in any respect or not found as per Guidelines issued by the College vide Notification No.SBSC/ 641 dated 27/08/2024
- iii. I and my supporters do not abide by the Code of Conduct and other guidelines issued by University of Delhi dated 31.07.2025, 08.08.2025 and 25.08.2025. I shall also abide by the decision of Hon'ble Supreme Court of India regarding Students' Union Election "University of Kerala v. Council, Principals, Colleges, Kerala and others" (Lyngdoh Committee Recommendation), Hon'ble Delhi High Court order dated 29.05.2018 and dated 11.11.2024 in W.P (C) No. 7824/2017 titled Prashant Manchanda v. Union of India & Ors (Defacement Case), The Delhi Prevention of Defacement of Property Act, 2007 and NGT order dated 29.01.2009 in this regard and the Metro Railways(Operaton and Maintenance) Act-2002 dated 17.12.2002 and the code of conduct prescribed by the University of Delhi as per the Supreme Court Judgment & Undertake to abide by the same. I also undertake to abide by the Order No.402/2015 of NGT.

I further declare that no disciplinary action leading to any punishment at the College / University level has ever been taken against me.
